Mayor Pro tem Seth Truesdall led the board in the Pledge of Allegiance

Mayor Pro tem called the meeting to order at 6:01PM

The board discussed the water meter fee and estimated how many would be charged. It will not effect the budget.

Mayor Pro tem Seth Truesdall opened the sid bids for trash.

TMAC - \$87,402/year - \$7283.50/month

Waste Management - \$93,836.28/year - \$7819.69/moths

No motion made to accept or deny the bids at this meeting.

The board discussed the Profit Handler Accounts – Each fund has its own profit handler account as it is a pass through account – no budget amount required.

The board discussed the ARPA funds for the Park and how it works. The Park must pay for the improvements then submit a reimbursement request.

The board discussed sidewalk at Sterling Meadows and from the city limits to Sterling Meadow. It is very dangerous for people to be walking on Hwy CC. It was suggested to look for a possible grant.

The board discussed the camera issue at Bailey Place. It was the consensus of the board for Mayor Pro tem Seth Truesdell to put the paperwork together and offer to 50% of the camering.
